Section 4. First aid measures

Eye contact : In case of contact, immediately flush eyes with cool running water. Remove contact lenses and continue flushing with plenty of water for at least 15 minutes. Get medical attention immediately.

Skin contact : In case of contact, immediately flush skin with plenty of water. Continue to rinse for at least 10 minutes. Remove contaminated clothing and shoes. Get medical attention if irritation persists. Wash clothing before reuse. Clean shoes thoroughly before reuse.

Inhalation : If inhaled, remove to fresh air.

Ingestion : Do not induce vomiting. Never give anything by mouth to an unconscious person. If irritation persists, get medical attention.

Section 5. Fire-fighting measures

- Flash point** : >93.3 °C (Closed cup)
- Hazardous thermal decomposition products** : Decomposition products may include the following materials:
carbon dioxide
carbon monoxide
nitrogen oxides
sulfur oxides
metal oxide/oxides
- Fire-fighting media and instructions** : Use an extinguishing agent suitable for the surrounding fire.

Dike area of fire to prevent runoff.

In a fire or if heated, a pressure increase will occur and the container may burst.
- Special protective equipment for fire-fighters** : Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode.

Section 6. Accidental release measures

- Personal precautions** : Use suitable protective equipment (section 8). Do not allow to enter drains or watercourses.
- Environmental precautions** : Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).
- Methods for cleaning up** : For small spills, add absorbent (soil may be used in the absence of other suitable materials), scoop up material and place in a sealable, liquid-proof container for disposal. For large spills, dike spilled material or otherwise contain it to ensure runoff does not reach a waterway. Place spilled material in an appropriate container for disposal.

- Handling** : Avoid contact with eyes, skin and clothing. Wash thoroughly after handling.
- Storage** : Keep out of reach of children. Keep container in a cool, well-ventilated area. Keep container tightly closed.
Do not store above the following temperature: 40°C
