Section 2. Hazards identification

Section 4. First aid measures

Eye contact : In case of contact, immediately flush eyes with plenty of water. Remove contact lenses and flush again. Get medical attention if irritation persists.

Skin contact : In case of contact, immediately flush skin with plenty of water. Remove contaminated clothing and shoes. Get medical attention if irritation persists. Wash clothing before reuse. Clean shoes thoroughly before reuse.

Inhalation : If inhaled, remove to fresh air.

Ingestion : Do not induce vomiting. Never give anything by mouth to an unconscious person. If irritation persists, get medical attention.

Section 5. Fire-fighting measures

- Flash point** : 35 °C (Closed cup)
Product does not support combustion.
- Hazardous thermal decomposition products** : Decomposition products may include the following materials:
carbon dioxide
carbon monoxide
- Fire-fighting media and instructions** : Use dry chemical, CO₂, water spray (fog) or foam.
- Use water spray to keep fire-exposed containers cool. Dike area of fire to prevent runoff.
Flammable liquid. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. Runoff to sewer may create fire or explosion hazard.
- Special protective equipment for fire-fighters** : Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode.

Section 6. Accidental release measures

- Personal precautions** : Use suitable protective equipment (section 8). Do not allow to enter drains or watercourses.
- Environmental precautions** : Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).
- Methods for cleaning up** : If emergency personnel are unavailable, contain spilled material. For small spills, add absorbent (soil may be used in the absence of other suitable materials) and use a non-sparking or explosion-proof means to transfer material to a sealable, appropriate container for disposal. For large spills, dike spilled material or otherwise contain it to ensure runoff does not reach a waterway. Place spilled material in an appropriate container for disposal.

Section 7. Handling and storage

- Handling** : Avoid contact with eyes, skin and clothing. Keep away from heat, sparks and flame. To avoid fire, eliminate ignition sources. Wash thoroughly after handling.
- Storage** : Keep out of reach of children. Store in a segregated and approved area. Keep container in a cool, well-ventilated area. Keep container tightly closed and sealed until ready for use. Avoid all possible sources of ignition (spark or flame).
Do not store above the following temperature: 35°C

Section 8. Exposure controls/personal protection

- Engineering measures** : Use only with adequate ventilation. If user operations generate dust, fumes, gas, vapor or mist, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. The engineering controls also need to keep gas, vapor or dust concentrations below any lower explosive limits.

Personal protection :

- Eyes** : Eye protection recommended.
- Hands** : For prolonged or repeated handling, use the following type of gloves: Impervious gloves.
- Skin** : No protective equipment is needed under normal use conditions.
- Respiratory** : A respirator is not needed under normal and intended conditions of product use.
