## Section 4. First aid measures

Eye contact : In case of contact, immediately flush eyes with cool running water. Remove contact lenses and continue flushing with plenty of water for at least 15 minutes. Get medical attention immediately.  
Skin contact : In case of contact, immediately flush skin with plenty of water. Remove contaminated clothing and shoes. Get medical attention if irritation persists. Wash clothing before reuse. Clean shoes thoroughly before reuse.  
Inhalation : If inhaled, remove to fresh air.  
Ingestion : Do not induce vomiting. Never give anything by mouth to an unconscious person. If irritation persists, get medical attention.

## Section 5. Fire fighting measures

<b>Methods for cleaning up</b>	: For small spills, add absorbent (soil may be used in the absence of other suitable materials), scoop up material and place in a sealable, liquid-proof container for disposal. For large spills, dike spilled material or otherwise contain it to ensure runoff does not reach a waterway. Place spilled material in an appropriate container for disposal.

<b>Handling</b>	: Avoid contact with eyes, skin and clothing. Wash thoroughly after handling.
<b>Storage</b>	: Keep out of reach of children. Keep container in a cool, well-ventilated area. Keep container tightly closed. Store between the following temperatures: 0 and 50°C
